Dear Mr. Strong:

Since receiving your phone call and the letter that followed I have searched my files for information pertaining to the 306<sup>th</sup> B.G. during W.W. II years and unfortunately found very little. After I was shot down I assume most of my records became lost in the shuffle.

I did find on old General Order No. 123 dated Dec 22, 1945 which awarded the Group the presidential citation for a mission flown on Feb 22, 1944 against Bernberg, Germany. It was not listed in the 306<sup>th</sup> Echoes on the attachment to your letter. I am forwarding it to you with a request that you return it. This was a mission in which I participated.

Thank you for sending the picture of my husband Al Schuering and his crew, taken during World War II. It will be treasured by someone in the family.


It is time that I reported the death of Col Alvin Schuering to your group newsletter, which I am still receiving. I am sorry to be so late in doing so, but there seems to be other business requiring my attention. Please use this information in your newsletter.

Alvin G. Schuering of Wheaton, Illinois died June 2, 1990 from Parkinson disease. He was born in Quincy, Illinois April 8, 1921. After 31 years in the Air Force, he retired as a Colonel in 1972. During WWII he flew B-17s over Germany and was a prisoner of war, after being shot down in 1944. He received the Distinguished Flying Cross and the Air Medal.

He served with the Strategic Air Command, the Joint Chiefs of Staff in the Pentagon, and as Commander of the Technical School at Chanute Air Force Base. In 1964 he was graduated from the National War College in Washington, D C and Lewis University in Glen Ellyn, Il with a law degree in 1979. He served with the DuPage County States Attorney from 1979-85.

He is survived<sup>by</sup> his wife of 42 years, Marie Walsh Schuering, five sons, one daughter, and eight grandchildren. Burial in Wheaton.

Family and friends (The Wabash River overflowed) Please include me on the Echoes mailing list, and here is my current address, telephone #, and first name.

were forced to seek accommodations in ~~surrounding~~ surrounding towns (Vincennes, INDIANA etc.) and content themselves with listening to the graduation ceremony as broadcast by local radio. We of class 43E were rescued and delivered to high ground by the Coast Guard and proceeded on leave with orders to report to Lockborne, Ohio for E17 check-out. Schuering, Stroffand, Tucker (in alphabetical order of class 43E) became left command in 8th AF in different Bomb Groups, shot down ending up in Stalag EW5 and all ending together after liberation, etc. at Chanote AFB
