Congratulations to all of us for a great reunion!



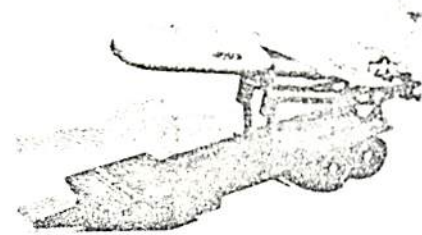
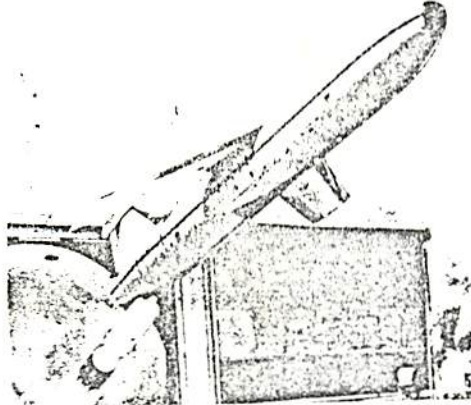

22 Years Ago...

In 1959, RS&H completed the first project which launched the firm into the missiles and space business. The approaching launch date, in April, for the first Space Shuttle further stimulates our keen interest in the initial testing of the launch facilities, designed by RS&H, and in the total program. This same deep interest predated the Space Shuttle in 1959, when RS&H was given a contract by U.S. Army Engineer District - Jax, and the Air Force, to design the G/M Launch Facility at Cape Canaveral, called "Complex 21." RS&H received high praise from the client for a complicated job well done under time pressure. The MACE Missile with a nuclear warhead was deployed, as the Project Director recalls, somewhere in Turkey. The Partner/Project Director was our current Board Chairman - **Paul M. "Mac" Huddleston**, and the Project Manager was our Executive V.P. - **Ralph W. Heim**. Since 1959, the firm has completed many projects connected with the space industry - at the



Cape, in Huntsville, AL (Marshall Space Flight Center), and other locations.

Thought you'd like to know about this 1959 project - well done!

Update on Projects

As work nears completion on refurbishment of the **Universal Marion Building**, now Charter Company Headquarters, Arch/Jax begins renovation of the top three floors of the **Ivey's Building**, also for Charter expansion.

The construction contract has now been awarded for the **Veterans Administration Medical Cntr. Research and Education Building** in Miami. We have been involved with this project since 1975, and have completed schematics, preliminary and contract documents. **Jim Shelley** will soon be inundated with the construction administration effort, which will last about 21 months.

Arch/Jax now has a total of **70 Atlantic Bank branches** to design. **Ron Masters** should be busy for some time!

RS&H/Merritt Island is completing plans and technical specifications for new 12" Fire Protection Water System for **Space Shuttle Mobile Launcher Platform No. 1**, and connecting piping on Launch Pad 39A. Construction work will be accomplished after launch of Space Shuttle **COLUMBIA**, scheduled for April.

In Jan. 1981, the MI office completed a feasibility study in connection with the Space Shuttle program at Vandenberg AFB. Another study for Vandenberg Weather/Security Enclosure Concept for Mobile Service Tower is in progress at RS&H/Jax, where the Model Shop is fabricating 1/48 scale model on both concepts. **Kennedy Space Center/NASA** is the client for both studies.

RS&H/MI is also providing shop drawings and on-site engineering services for the \$18 million construction contract for the Rotation Service Structure (RSS) for Shuttle Launch Pad 39B.

New Projects

The **Environmental Division, Jax**, has a new 1-yr. continuing service contract for consulting services for solid waste disposal, site studies for transfer stations, etc., for **Metro Dade County**.

Another new contract for **Environmental Division** - the Environmental Protection Agency (EPA) approved the Infiltration/Inflow Study for the **City of Jacksonville** on 12/19/80. **Bill Mendez** was Project Manager for the study and will remain a Project Manager for the **Sewer System Evaluation Survey**, which has been awarded to RS&H by the City. This project will identify the infiltration and inflow sources on the 620-miles of sewer system conveying into the Buckman treatment plant. Total fee for this project is \$1.3 million and 32,500 man-hours is the estimate to complete the project in a period of 11 months.

RS&H was awarded the Site/Master Plan project for **Tampa General Hospital**. Special recognition to **William J. Webber, Robert F. Darby, Ben F. McMurry, Jr., Allen Smith** and **Joe Bozick** for their fine presentation to the selection committee of the Hillsborough County Hospital Authority.

Ground has been broken for construction of the **Barnett Plaza**, a 15-story, 197,000 sq.ft. office building in downtown **Orlando**. **John Schwanebeck, Tampa**, is Project Manager and **D. L. "Jake" Jacobs** of **TRIGON Construction Mgmt.** has been assigned the position of Resident Engineer.

The **Planning Division** has been selected to develop a master plan and improvement program for **Qatar Air Wing Base in Doha, Qatar**. **Howard Landers, Jack Smith, Joe Ehardt** and **Barry Campbell** were recently in Qatar, working on this project!

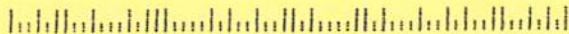


