SUBJECT: Intelligence Report.

TO : Commanding Officer, 306th Bombardment Group (H).

1. Hot news.
2 B-17's went down at 47° 08' N, 3° 12' W at 1300 hours.
Seven chutes reported.
1 B-17 seen returning to French coast with wheels down and being circled by E/A.
2. Narrative.
27 A/C took off at 1000 hours to bomb the aeroplane assembly works at Nantes, France. 22 A/C bombed the target; one more went over target but failed to bomb and four returned early. The route was as briefed.
3. Bombing.
Bombing was undoubtedly exceedingly good. Negatives just developed confirm target obliterated by billowing clouds of smoke from bomb bursts. Crews say "We won't have to go back there any more." "Group pattern a beaut." "Right in the eye."
4. Abortions.
(a) 1 turned back at 1120 hours at Church Lawton. #2 prop ran away.
(b) 1 turned back 12 miles from English coast. #1 engine throwing oil.
(c) 1 turned back at 1140 hours at rendezvous. #3 prop ran away.
(d) 1 turned back at 1206 hours at French coast. Could not stay in formation due to lack of power.
5. Enemy aircraft.
35 to 50 E/A were encountered by the 306th Boab Group. They were mostly Fw 190's with some Me 109's. Two Ju 88's were seen well out to sea. Fw's were yellow, red and blue nose, all silver. Me 109's reported as light tan.
E/A first sighted near IP at 1240. Attacks started right after bombs were away at 1249 and continued well out to sea until about 1315. 2 Ju 88's were seen at 1335, and made two passes at formation.

Most attacks were made by single E/A out of the sun on the tail position, from 3 to 9 o'clock, some being pressed home to within 200 yards.
6. Flak.
At Nantes, formation at 23,000, heavy, moderate, black, accurate, continuous following. First bursts were low but following bursts worked up into the formation. Ten ships report some damage due to flak.
7. Observations.
A convoy of 5 ships reported proceeding south, under escort, at 47° 38' north, 04° 29' west. Sighted at 1256 from a height of 18,000 feet. Large plant, five long buildings, one painted red, 1½ miles SW of Laval. Grass airfield reported just north of Laval. A big installation reported NW of Chateaubriant.
Three aerial bombs were reported. One is reported to have damaged the lead ship, the smoke of the burst being large enough to obscure the tail assembly. The pilot of the damaged A/C thought the injury due to flak, his wing man reporting the bomb.
No fighter cover seen.

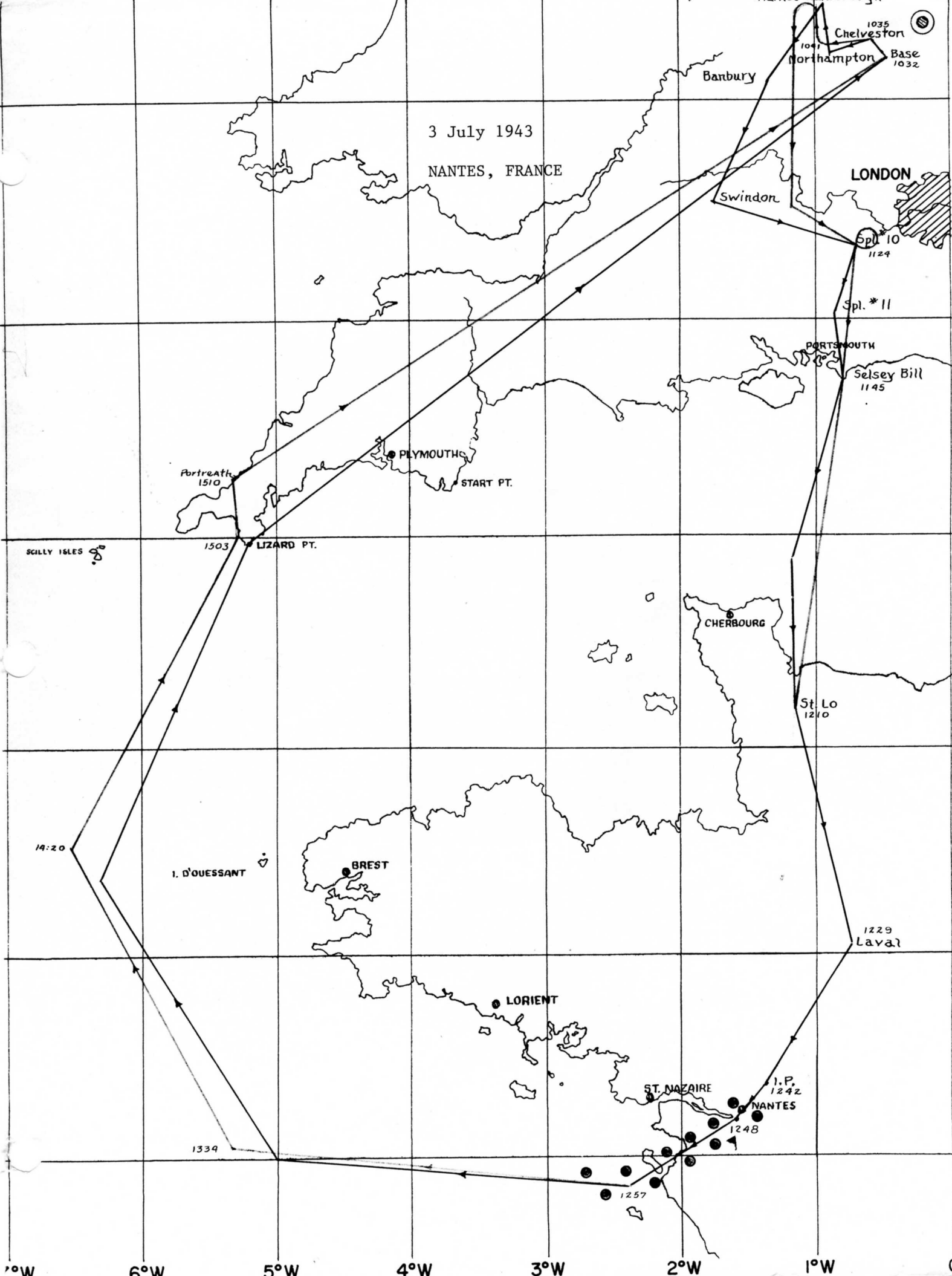

1248 hours.- Heavy, black, moderate, accurate, continuous following. One crew reported good concentration, but all others reported continuous following. First bursts were low, but following bursts were & worked up into the formation.

1240 hours.- At IP - Heavy, black, meager.

1256 hours.- After leaving French coast - flak ship - light, inaccurate, meager.

11. Any other Comments, Phenomena, etc.
A/C #894 reported seeing an aerial bomb dropped near A/C #306. The burst blotted out the tail assembly from view. In all three aerial bombs were reported. A/C #306 reported the damage as flak damage.
